ACN	Anglia Cancer Network - A non-profit organisation which seeks to heighten public awareness of cancer in order to improve rates of early diagnosis, and to improve the quality of life and treatment of those who already have been diagnosed.

C&C	Coast and County – One of four collaborative groupings consisting of member practices. 35 of the 38 practices within the IESCCG geographical area belong to one of four collaborative groups. Coast and Country is one of these collaborations consisting of the following member practices: Eye, Fressingfield, Mendlesham, Bildeston, Constable Country, Holbrook, Needham Market and The Grove.
CDS	Commissioning Data Sets - Organisations that provide NHS-funded care must submit activity data via the relevant Commissioning Data Sets; these include to the Secondary Uses Service (SUS), Unity 2, SSNAP and Open Exeter.
CCOG	Collaborative Commissioning Oversight Group - Developing a more collaborative approach to the commissioning of specialised services.
CCP	Community Care Practitioners
CCP	Complex Case Panel
CE	Clinical Executive – Is effectively the engine room of the CCG. Its members lead the teams that get things done and ensure that plans are implemented.
CQC	Care Quality Commission - A monitoring body to insure the hospitals, care homes, dentists and GP surgeries in the localities are meeting national standards.
CCG	Clinical Commissioning Group - After the 2012 NHS and social care act, the Government created hundreds of CCG's to replace the Primary Care trusts (PCT). The CCG'S primary responsibilities include commissioning health care services for patients (see definition for 'commissioning' below), and to act as a point of contact for the public in both informing them of new healthcare models, and receiving feedback. At the core of the decision making process of the CCG is the governing body, which is a committee made up of Health care professionals (for definition of governing body see below)
C-Diff	Clostridium Difficile - Is a type of bacterial infection that can affect the digestive system. It most commonly affects people who have been treated with antibiotics. C-Diff can lead to life threatening conditions.
CDI	Children's Depression Inventory - Is a psychological assessment that rates the severity of symptoms related to depression and/or dysthymic disorder in children and adolescents.
CEAC/TIAA	Now merged, TIAA is an independent business assurance provider.
CEIF	Controlled Environment for Finance – A restricted area for finance team members working with patient identifiable data.
CEP	Community Engagement Partnership - Community engagement is the process of involving people in decisions that affect them.
Connect East Ipswich and Connect Sudbury	There are two early adopter sites in Suffolk for Connect – Connect Sudbury covers the town and the rural area surrounding it. Connect East Ipswich covers much of, but not all of, IP3 and IP4 postal districts. These are important projects because they are testing out new ways to deliver your future health and social care.

CHC Framework	The National Framework for NHS continuing healthcare and NHS-funded nursing care is a Department of Health policy document first introduced in October 2007. The document: <ul style="list-style-type: none"> • Sets out clear principles and processes to be followed throughout England for establishing eligibility for NHS CHC. • Clarifies the interaction between the assessment for NHS CHC and NHS funded nursing care. It aims to minimise local interpretation and improve the transparency and consistency of the decision-making process by providing: <ul style="list-style-type: none"> • Guidance to be followed by all involved in the assessment process; • A national assessment process and three tools to support decision-making: The Checklist, Decision Support Tool and Fast Track Tool • Common paperwork to record evidence that will inform decision-making.
CFS	Chronic Fatigue Syndrome - Is the common name for a group of significantly debilitating medical conditions characterised by persistent fatigue and other specific symptoms that lasts for a minimum of six months in adults (and 3 months in children or adolescents).

CIP	Cost Improvement Plan - Is the identification of schemes to increase efficiency/or reduce expenditure.
CIS	Community Intervention Service – Combination of a number of different professionals from Social Care Services and the Health Service. These multidisciplinary, integrated teams provide support to people who require a period of short-term intervention. This could be following a planned or unplanned admission to hospital or to avoid an unnecessary admission to hospital or long-term care. A key aim of these services is to minimise dependency upon services as is safely appropriate.

IFR	Individual Funding Request - Where no policy exists for a very rare condition or experimental medicine, the CCG have set up an Individual Cases Process, to consider the circumstances of individuals, for whom a referral outside existing pathways may be appropriate. This usually relates to patients with rare conditions, or for more experimental treatments where there is limited evidence. In such instances, the referring clinicians should obtain an Individual Funding Request form.

IOP	Intraocular pressure - Is the fluid pressure inside the eye. Tonometry is the method eye care professionals use to determine this. IOP is an important aspect in the evaluation of patients at risk from glaucoma. Most tonometers are calibrated to measure pressure in millimetres of mercury (mmHg).

IPC	Ipswich Primary Care - One of four collaborative groupings consisting of member practices. 35 of the 38 practices within the IESCCG geographical area belong to one of four collaborative groups. IPC is one of these collaborations consisting of the following member practices: Barrack Lane, Ivy Street, Burlington Road, Derby Road, Hawthorn Drive, Felixstowe Road, Two Rivers Medical Centre, Orchard Street, Ravenswood Medical and Solway & Mallick.
ISCRE	Ipswich and Suffolk Council for Racial Equality – Its main purpose is to support the elimination of unlawful discrimination on the grounds of people’s race, sex, disability, age, marital and civil partnership status, pregnancy and maternity status, sexual orientation, gender reassignment, religion or belief.
IT (or sometimes known as ICT)	Information Technology - The application of computers and telecommunications equipment to store, retrieve, transmit and manipulate data.
IIT	Invitation to Tender - Initiating step of a competitive tendering process in which qualified suppliers or contractors are invited to submit sealed bids for construction or for supply of specific and clearly defined goods or services during a specified timeframe. Also called request for tenders.
IHUG	Ipswich Hospital User Group - Meets every six weeks and involves a representative from every user group, a worker from Suffolk Family Carers, senior Trust staff and Trust Board Members. The meeting is an opportunity to exchange information and ideas and have open discussions about the policies and strategies of the hospital.
IESCCG	Ipswich and East Suffolk Clinical Commissioning Group
IPCN	Infection Prevention and Control Nurse
IPHWI	Improving Population Health and Wellbeing by the use of Information, Intelligence and Innovation
IPR	Integrated Performance Pack - Provides members with a summary of performance against national targets, contractual targets, clinical quality and patient safety issues, financial performance and acute activity.
ISA	International Standards on Auditing - are professional standards for the performance of financial audit of financial information.
IVF	In Vitro Fertilisation - Literally means ‘fertilisation in glass’ giving us the familiar term ‘test tube baby’. During the IVF process, eggs are removed from the ovaries and fertilised with sperm in the laboratory. The fertilised egg (embryo) is later placed in the woman’s womb.

LAC	Looked After Children - The guidance concerns the delivery of services from health agencies and local authorities to promote the health of looked after children and young people. It is written in the context of a holistic model of health which takes account of wider determinants of health and wellbeing. It is therefore relevant to all Children’s Trust partners.

LEP	Local Enterprise Partnership - In England, local enterprise partnerships are voluntary partnerships between local authorities and businesses set up in 2011 by the Department for Business, Innovation and Skills to help determine local economic priorities and lead economic growth and job creation within the local area.
LLTF	Living Life To The Full
LRO	Legislative Reform Order - Section 1 of the Legislative and Regulatory Reform Act 2006 (the "LRRRA") gives Ministers certain powers to make orders ("legislative reform orders") that remove or reduce burdens resulting directly or indirectly from legislation, and section 2 makes similar provision in relation to orders that promote principles of better regulation. Section 3 sets out facts that the Minister proposing to make a legislative reform order has to address. They include positive tests (need for legislation, proportionality and fair balance of interests) and negative ones (no removal of necessary protection, no unreasonable interference with rights and freedoms, no constitutional significance).
LES	Local Enhanced Services - Schemes agreed by CCGs in response to local needs and priorities, sometimes adopting national service specifications.
LETB	Local Education and Training Board - Local Education and Training Boards are responsible for the education and training of health and public health workers at a regional level. They are committees of the national body, Health Education England (HEE).
LMC	Local Medical Committee - Local representative committees of NHS GPs and represent their interests in their localities to the NHS health authorities. They interact and work with – and through – the General Practitioners Committee as well as other branch of practice committees and local specialist medical committees in various ways, including conferences.
LOC	Local Optometry Committee
LOCSU	Local Optical Committee Support Unit
LOS	Length of Stay
LPC	Local Pharmaceutical Committees (LPCs) represent all NHS pharmacy contractors in a defined locality.
LRTI	Lower Respiratory Tract Infections
LSCB	Local Safeguarding Children Boards - Were established by the Children Act 2004 which gives a statutory responsibility to each locality to have this mechanism in place. LSCBs are now the key system in every locality of the country for organisations to come together to agree on how they will cooperate with one another to safeguard and promote the welfare of children. The purpose of this partnership working is to hold each other to account and to ensure safeguarding children remains high on the agenda across their region.
LSP	Local Service Provider - Supports the Department of Health in delivery against LSP contracts. The LSP contracts deliver critical systems and services to the NHS.
LTC	Long Term Conditions - E.g. mental health illness.

MoM	Map of Medicine Health guides encourage joint decision-making between a patient and their doctor through a care map – a clear visual representation of the options available for managing the condition.
MASH	Multi-Agency Safeguarding Hub - A typical MASH is the central resource for receiving all safeguarding and child protection enquiries. The MASH is staffed with professionals from a range of agencies including police, probation, fire, ambulance, health, education and social care. These professionals share information to ensure early identification of potential significant harm, and trigger interventions to prevent further harm. MASH staff gathers information from every agency and use this to decide the most appropriate intervention to respond to the child's identified needs. Where appropriate, the MASH team is able to immediately trigger a response. The emphasis is on triggering interventions to the child or young person and their family to prevent harm.

MCA/MCA Training	The Mental Capacity Act 2005 - Creates a framework to provide protection for people who cannot make decisions for themselves. It contains provision for assessing whether people have the mental capacity to make decisions, procedures for making decisions on behalf of people who lack mental capacity and safeguards.

MDDC	Multi-Disciplinary Diagnostic Centre
MDTs	Multi-Disciplinary Teams - A group composed of members with varied but complimentary experience, qualifications, and skills that contribute to the achievement of the organization's specific objectives.
MECC	Making Every Contact Count - Encourages conversations based on behaviour change methodologies (ranging from brief advice, to more advanced behaviour change techniques), empowering healthier lifestyle choices and exploring the wider social determinants that influence all of our health.

MEIC	Making Every Intervention Count - Making Every Intervention Count is the programme of work that will focus on re-shaping Children and Young People's Services so they remain effective into the future and provide the best possible outcomes for children and families within available resources.
